RULES AND REGULATIONS OF KRISHNA NIKETAN

1. These rules and regulations shall be called rules of the 'Krishna Niketan' Society.

2. Definition:

1. The Society shall mean the Krishna Niketan.
2. The Executive Committee shall mean the body which is constituted as such under rules as the Executive Council of the society.
3. The President/Chairman/Founder Chairman and the Secretary shall mean the Founder Chairman and the Secretary of the Society.

3. Membership:

1. The membership of the society shall be open to any individuals.
 - A. Who subscribes to the aims and objectives of the society.
 - B. Applies in writing for membership.
 - C. Pays the prescribed fee for membership.
 - D. Duly elected by the executive committee or general body.
 - E. Proposed and seconded respectively by members of the Society.

2. Members of the society shall have the right to nominate two representatives to act for it and participates in the activities of the society, having each one vote to all the executive committee and of the General body of the society.

Classes of Membership:

1. Patrons who give a minimum lump sum donation or invited by the executive committee.
2. Life Members:
Ones who pay the non-recurring fee as fixed by the committee.
3. Hony. Members:
Who have made outstanding contribution in the educational field. He is exempted to pay fees.
4. Members:
Who pays recurring fees as fixed by the committee. In addition those individuals who are listed as founder member in the rolls of the society, shall continue to be enrolled as founder member.

Termination of Membership:

1. The membership of any person shall be deemed to have terminated upon his or its
 - A. Failure to pay membership fee.
 - B. Resignation in writing.
 - C. Being adjudged insolvent or certified as of unsound mind.
 - D. Default which in the opinion of General Body or Executive Committee is detrimental to the interest of the society.

Rules of the Society:

1. Every member of the Society shall be bound by its constitution and bye-laws. Every member shall enjoy all the benefits provided by the Society. Members shall have the right of the voice and vote in all the meetings of the general body.
2. The property and income of the society shall vest in the executive committee and shall be applied solely towards the promotion of the

aims and objectives of the Society, no portion shall be paid out or transferred or otherwise disposed directly and indirectly by way of dividend, bonus or otherwise however to the member of the society, provided, however that nothing herein contained shall prevent the payments in good faith or remuneration to any officer, teaching staff or other employees of the society or any individual towards services rendered to the society.

Funds:

The funds of the society among others shall consist of:

- Revenue from subscription or membership or donation.
- Fee charged from student's terms Training programmes.
- Grants from government.
- Sales proceeds of any publication.
- Proceeds from any gathering, conferences, educational performances and all other function organized by the society.

Executive Committee:

The affairs of the society shall be managed by executive committee shall be of five (5) years.

The co-opted members of the executive committee shall retire each year. A co-opted member of executive committee shall be eligible for election of co-option upon retirement.

Persons are eligible for election to the executive committee eligible who shall have been members of the society for at least one year. Employees of the Society shall not be eligible for election to executive committee.

Except in the case of any matter expressly declared as within the competence of the general body or a change in the constitution the executive Committee shall be generally responsible for the implementation of the aims and objectives of the societies. Subject only to the intimate authority of general body.

Nomination to and election of the executive committee:

A. The executive Committee shall not less than thirty calendar days before the prescribed date of the annual meeting of the general body, invite from the members nominations as candidates, to the elected to the executive committee for the coming year. Such nominations shall be duly proposed and seconded respectively by the members of the society and shall be received by the executive committee within the ten days after the date of invitation.

All nominations thus received shall conspicuously posted in the premises of the society and shall be submitted in writing to the

member at least 15 (fifteen) days before the annual meeting of the general body. At the annual meeting of the general body election of members to be executive committee shall proceed by secret ballot and in accordance with the bye-laws framed for such annual meeting.

Duties of Executive Committee:

A. The executive committee of the society shall select from among its members of the office bearers of the society viz.

1. A President, who shall be Indian.
2. One Member Secretary.
3. One Treasurer.

And at least four members.

The office bearers shall serve for five years and shall be eligible for re-election upon retirement. The member secretary on behalf of the society shall represent the society, attend its functions, keeps its records and in general be responsible for carrying out the societies aims and objectives and act as Managing Director.

B. The executive Committee shall meet at least once every calendar month. A quorum for such meeting shall be not less than five members. A meeting shall stand adjourned if no quorum shall be necessary at such adjourned meeting.

C. The executive committee shall have the power among others to

1. Appoint committee or sub-committee from among the members, which shall be directly responsible to the executive committee.
2. Delegate to such committee or sub-committee such of duties and powers as it deems fit for carrying out effectively and activity of the society.

3. Enact bye-laws as it may deem fit consistent with the constitution and with the aims and objectives of the society.

4. Determine fees for the several categories of membership in the societies subject to the approval of general body.

5. Enact upon membership applications including the power to reject such applications without having to assign any reason for such rejection.

6. Appoint necessary stipendiary staff to function as Directors. The Directors may be invited to sit at meeting of executive committee without right of vote.

7. Acquire and manage movable and immovable property in according with the provisions made above.

8. To borrow money with or without interest from any commercial bank or financial institution, or society, or trust, or body corporate, or individual for the purpose of the construction of the building for school, or development of the land, on which the building shall be constructed and which has been acquired by the society at new Bypass Road, Patna. The said borrowing may be unsecured or secured either by the mortgage or by a charge on the said land and building, or any other assets of the society.

09. Annual meeting of the General body:

The Financial year of the society shall be the calendar year. 'General Body meeting shall be held in once in a year regularly'. Notice for such

meeting shall be addressed to every member at least 15 (fifteen) days prior to the date of the meeting non-receipt of the notice by any member shall not invalidate the decisions arrived in the meeting.

The quorum for the annual meeting of the general body shall consist of twenty members or one fifth of the total numbers on the roll of the society as on the 1st January of the year in which such meetings is to be held, whichever is less.

The Chairman shall preside over all the meetings of the society (or in his absence, Member Secretary Cum Director or any one of the members proposed and seconded by members).

The meeting shall:

A. Consider the annual report submitted by the executive committee along with the audited accounts of the society for the previous year.

B. Appoint election supervisor and elect members of the executive committee.

C. Act upon bye-laws as proposed by the Executive Committee.

D. Appoint Auditors.

E. Transact any other business of which notice may have been given along with notice of the Annual meeting of the general body, or which may be permitted by the presiding officer as such meeting. On roll questions at the regular Annual Meeting of the General body requiring a vote, a simple numerical majority of those voting shall declared except as provided in Sec. 12&13.

10. Power (Treasures):

The treasure shall have the right to maintain all the accounts, matters and papers and on requisition made by the Secretary or authorized

persons. The treasurer can draw the amount with the signature of Secretary of this society.

11. Extraordinary General Meeting

The executive committee may when it deems necessary or shall when requested by one third of the total members of the rolls of the society or thirty members whichever is more by a resolution in writing call an extraordinary general meeting for a specific purpose which in the opinion of the committee or the requisitioners, it cannot wait for decision until the annual meeting of the General body.

The procedure of calling such a meeting shall be the same as for the annual meeting being confined to the specific purpose mentioned in either the notice or requisition. A quorum for such an extra ordinary general meeting shall consist of 1/5th of the total number of the members rolled or thirty members. In case a quorum is not present at such extra ordinary meeting, the meeting shall stand adjourned until recalled as provided above.

12. Alteration to the Constitution

No alteration of the constitution shall be effected unless it shall have been carried by a majority of not less than 2/3rd of the members present and voting at a general body meeting of which fifteen days notice shall have been given. Non receipt of a notice of meeting by any member or non receipt within a period of time mentioned in this constitution shall not invalidate the proceeding of the meeting.

13. Dissolution of the Society

The society shall not be wound up except by a special resolution. To wind up or dissolve the society resolution has to be passed by a majority

or not less than three fourths of the members personally present and voting of an extra ordinary general meeting of the society of which notice shall be given to ever member twenty clear days before the date of the meeting and setting out full particulars of the resolution proposed and the reasons therefore. In case of wind up the society its movable and immovable properties may be transferred to similar type of society or to the government.

14. Interpretation

Power and Functions of Office Bearers

Chairman:-

The Chairman shall preside over the meeting of the society and in case of any dispute regarding interpretation of the Memorandum of Society or Rules or on any other matter of the Society with Chairman's opinion shall be final and binding. He shall have casting vote. In case of equality of votes in addition to his own vote he is entitled to as a member.

15. Treasurers

The treasurers shall be responsible for all accounts. He shall operate Banking account/ accounts of the Society jointly with the Secretary cum Managing Director. He shall deposit all sums received in the Bank Account of the Institute. He shall pay all bills which are passed for payment by the statement of receipts and expenditure in the meeting. He shall prepare the account of the whole year.

16. Inspection of Register

All the registers of the Institute shall be available at the registered office where member or members can inspect the proceeding book, accounts register and membership register with prior permission of Secretary cum Managing Director or Chairman.

17. Amendment

No addition and/or alteration shall be made in the Rules of the Society unless the intended addition or alteration has been included in the agenda circulated among all the members and passed with at least 3/5th majority of votes at a General Meeting convened for the purpose, or at the Annual General Meeting.

18. Accounts and Audit:

Accounts of the society shall be maintained or operated by the society Secretary and Treasurer.

The Income and Expenditure of the Society will be audited regularly and audited every year by an auditor appointed before 31st of March by the General Body.

(i) The Inspector General of Registration can at any time, at his discretion, get the Society audited by a recognized Chartered Accountant. The fees of the Chartered Accountant for this audit will be borne by the Society.

(ii) Operation of Bank Account – The Society shall open its bank accounts as per the resolutions adopted by its managing committee. The bank account of the society shall be operated jointly by the Founder Chairman along with any one of the Treasurer or Secretary or as decided by the Governing Body.

(iii) Legal Proceeding – Secretary shall do all the legal proceeding on behalf of the society.
